The Korean American Bar Association of Southern California (KABA) cordially invites you to our **43rd Annual Installation Dinner on Thursday, April 27, 2023**, at the California Science Center in Los Angeles. A cocktail reception will be held from 6 p.m. to 7 p.m., and the dinner program will run from 7 p.m. to 9 p.m.

Founded in 1980 by pioneering Korean American attorneys, such as KABA's first president, the Honorable Kenneth Chang, KABA is a pro-bono organization dedicated to serving the Korean American community in Southern California and the diverse Los Angeles community at large. In addition, KABA plays an active role in the movement for a diverse judicial bench in California and in championing causes for the disenfranchised.

For over twenty years, KABA has worked with the Legal Aid Foundation of Los Angeles (LAFLA) to provide free legal assistance to thousands of residents in the greater Koreatown community through monthly walk-in clinics. Even during the COVID-19 pandemic, KABA has continued to provide free monthly educational webinars in conjunction with Asian Americans Advancing Justice Southern California, the Korean American Coalition, and the Consulate General of the Republic of Korea in Los Angeles, covering various time-sensitive issues that directly impact our community. Last fall, KABA resumed its in-person legal assistance through a Naturalization Clinic co-sponsored by LAFLA, and this year, KABA will continue to organize more in-person legal assistance and events to serve our community on a regular basis.

Since its inception, KABA has been devoted to creating opportunities for our members to network with other legal and non-legal professionals through various mixers and sponsorships of sister bar organization events. To help our members in their professional development, KABA has hosted topical MCLE programs, launched a mock interview program for law students, and provided a mentorship program that matches law students and junior attorneys with more senior attorneys. Such programming over the years has helped shape past, current, and future generations of legal professionals in Los Angeles and beyond.

To ensure the best representation of your ad, follow these guidelines:

Ads with text only and no images can be sent as an attached MS Word file. We will create a design for you.

We work on PC and Macintosh systems and have the ability to read many types of files, including Acrobat, QuarkXpress, Illustrator, Photoshop, and MS Word.

Image files, logos, photographs should be EPS, TIFF, or JPEG files, minimum 300 dpi.

Any image file created in a word processing program is incompatible, including files created in MS Word, PowerPoint, and Excel.

All fonts should be e-mailed along with your artwork.

When sending your logo via e-mail, do not encode or encrypt the files; simply send them as an attachment.
